 - Accommodating Employees with Pregnancy Disabilities: If an employee's limitations resulting from a pregnancy-related medical condition rise to the level of a disability, the employer may need to provide the pregnant employee with reasonable accommodations to enable the employee to perform her job duties. Discussed in this release, the EEOC Enforcement Guidance on Pregnancy Discrimination and Related Laws set forth a list of various types of accommodations that employers may need to consider in order to comply with their ADA obligations.
- [ADA: Public Accommodations and Commercial Facilities](#) (Pub. #00439) – [Release 33](#): Complying with the requirements of the ADA is always a challenge for a L&E attorney.  - Alternative Accessibility: The ADA requires public accommodations to remove architectural barriers to accessibility where such removal is readily achievable, which is defined as being without significant difficulty or expense. Where removal of an architectural barrier would not be readily achievable, the public accommodation must seek to provide an alternative means of accessibility. In *ORLANDA V. LAS ALAMETOS RACING ASSOCIATION*, the Federal District Court for the Central District of California held that a racetrack clubhouse had provided appropriate alternative means of access, where installing a ramp at the entrance stairs was not readily achievable.
